This does not only keep them apart from their right to life but also does not make them even live their life.

something that you can choose to engage in or not and many people either choose to go with

old thinking or some choose to go with new thinking and amalgamation of these two. This can be seen through the support of elders in live-in relationships and their finding a live-in partner

in their 60s or late 60s. As per the one survey conducted in Pune, Maharashtra, about 70% of

seniors were open to the idea of a live-in-partner. But on the same thing, many of their children

opposed the idea. The Same happens with youngsters who belong to the LGBT Community

and due to the stigma, and fear of parents and society, they do not come out of the closet and

if come they go through uncountable challenges and issues. Society supports straight marriages

where the husband treats his wife like a thing and gives no value to her, beats her, and keeps

torturing her but society does not support the couple which belongs to the LGBT community

and respects each other.

All these things are rights but there needs to be some limitations just to not let the chaos arise in society and to maintain law and order. In a recent judgment by the Madras High Court in the case of *P. Jaychandran vs A Yesuranthinam and Ors (Appeal Suit No. 340 of 2016)*, the Court stated that an extramarital relationship between a married man and another woman cannot be termed as 'live-in-relationship'.⁸

Society runs in the right direction and in a better way when it follows the mixed nature of thoughts or thinking rather than sticking to one pattern or stereotype. Every culture is rich but Journal of Legal Research and Juridical Sciences the over-domination of any group or person leads one to blame or hate the entire culture, customs, or traditions.

Limitations imposed today will not be suitable or will not belong to the limitations anymore in the future. Freedom, rights, and limitations always change their nature over time, and following the same for years and years creates a mess. That's why it needs to have a strong flexible nature without altering or causing harm to the basic principles like morality and humanity. Principles are also set as per the time they too can be changed if it feels necessary.

Korowai from the rainforests of Papua in Indonesia, Yanomami from Amazon and Venezuela, Jarawa from the Andaman Islands, Ayoree from Paraguay and Bolivia, etc. 10

All these tribes and groups are so different from our world and still live the way they used to live hundreds of years ago.

DEVELOPMENT OF COUNTRY AND WAY OF THINKING

The developed country in the eyes of today's world is a country that has many missiles, nuclear power, a strong defense system, and an army. America, Russia, China, and North Korea are such countries considered developed and have a very strong base and defense system and mechanisms. Countries mentioned here like China, Russia, and North Korea have strong defense systems. They might be at the top in such things but at the same time, they have lower rank in the freedom index. Other countries like Sudan, Syria, Iran, Iraq, and so on also share the same page of lower freedom index. ¹¹

The reasons behind having low happiness and freedom rates can be the type of government, discrimination due to culture, and dominance over one group by another. These reasons have their roots and emergence in the way of thinking and stereotypes that do not let other people enjoy their right to life. Limitations too gave their limitations. A foot of limitations stepping out of the frame of limitations becomes the sole reason for depriving one of his rights and becomes the reason for further consequences.

The Universal Declaration of Human Rights (UDHR) is a declaration of human rights that treats all people equally and gives or declares the rights to all as human beings. Article 1 of the UDHR says that "All human beings are born free and equal in dignity and rights". This Article alone says that we have the rights from our birth and no one can deny them to us unless it is a matter of law.¹²

The same has been mentioned in Article 21 of the Indian Constitution, "No person shall be deprived of his life and personal liberty except according to the procedure established by law. Footnote 11 means that a person can have all the rights under the right to life but if it causes trouble to others or society or enters into arbitrariness then the state has the right to capture the person and curtail his liberty but cannot deprive him of other rights unless the Court declares him as guilty for any severe offense and gives capital punishment.¹³

The development of a country and its way of thinking depends on the environment of the country, like what type of thinking, people, culture, and traditions we have been surrounded by. Our choices decide our future and sticking to the same way or pattern of thinking will lead to us nothing. If denying to accept the change will continue then we will always be at the same place, point as we are today. Discussing more such things shifts our focus from the main things or matters of society like basic needs, infrastructure, and so on.

Laws do not only need the sanction from the government or the public or society; they need to be sanctioned and accepted by both otherwise they will have no value and will not benefit the people for whom it is or has emerged. Government and society work hand in hand one cannot run the entire nation and society otherwise it will be a monopoly of either people or government on society.

The thinking cannot be changed completely but we can try to think about particular things in a different way which will lead us to stand in a better and firm way. Things never work the same; the direction is what makes the difference in the results.

The UDHR and constitution of various countries with the provision of rights also established a body or a separate department for the promotion and protection of all these rights. The Human Rights Commission is one of the best examples of this statement. It exists on both national and Journal of Legal Research and Juridical Sciences international levels. Many other organizations like the United Nations and NGOs like Amnesty International also work in this regard by arranging events or by organizing campaigns and fights for human rights throughout the world.

All these legal bodies and organizations have established security in one's mind that the rights are protected and there is a remedy available in case of any violation of these rights or if someone prevents one from getting the rights.

The social limitations in the case of UDHR and the constitution have less value as they cannot be forcefully applied to one. Limitations are given by the law itself not to discriminate or dominate but to protect everyone equally with equity, liberty, and dignity.

Life of social limitations with the emergence of laws and their binding nature has been changed and itself get limited but the lives of people have grown and developed which every state and

its citizens dream of. Though the Constitution plays a significant role in society and country, some of the strict provisions still need amendments from time to time to protect the core, stand, and base principle of humanity and of the Constitution itself.

In the case of life before and after the constitution the main thing of great notice is the legally binding nature of the laws and the judgments on that particular state and its people. The mandatory authority in the U.S. shows the binding nature of decisions. As per this authority, All courts, federal and state, are bound by the decisions of the U.S. Supreme Court on U.S. Constitutional and other issues of federal law. 15

GENERATION GAP AND TURNING POINT OF CHANGE

The generation gap specifically mentions the parents and children in the frame of society. Parents have many life experiences and children have life experiences the common thing in both groups is a decision and the way they think about particular things either because of their environment or of the period they belong to.
