Furthermore, Section 125 of the Criminal Procedure Code allows elder parents to claim maintenance from their children. The Maintenance and Welfare of Parents and Senior Citizens Act of 2007 establishes legal grounds for children or heirs to be responsible for the maintenance of their parents or senior family members.<sup>3</sup>

They may be affected by provisions of family law which affects their relationship with their grandchildren. While precise legal definitions may be absent, allusions to statutes and court rulings underscore the acknowledgment of grandparents' visitation rights, underscoring the broader cultural context and the pivotal role of familial bonds in a child's upbringing. Legislative amendments and judicial decisions pave the way for broader cultural and societal dimensions. The courts when dealing with matters of custody and visitation should consider the advantages a child derives from a relationship with their grandparent who recognizes the tradition and cultural practices.<sup>4</sup>

## **CUSTODY AND VISITATION RIGHTS**

Children develop stronger emotional connections with grandparents and these bonds can become challenging when their parents get divorced. Grandparents who share a deep and close relationship with a child have the right to go to court and get their visitation rights. In numerous states, courts base their decisions solely on what is deemed in the best interests of the child when considering such requests. Although the legal landscape is not fully settled, these permissive statutes have generally withstood challenges and typically require a reasonable justification to grant visitation rights to grandparents. Many states have altered and amended laws to consider the wishes of both parents and children. In some circumstances, for granting visitation rights to see minor grandchildren, the power rests with the parent's decision. States also allow parents to restrict grandparents' interactions with their children. Mediation with the parents is a good approach for grandparents to handle this kind of scenario.

To seek full custody of a grandchild, grandparents have the right to file a petition in the court. But courts prefer children to reside with their parents. This situation occurs when the parents of the child are deceased, unfit for custody, or if the child was residing with grandparents for one year or more. In all these cases of child custody, the court strives to determine the arrangement which is best in the interest of the child by considering many factors such as the child's blood relatives, relationship with their grandparents, grandparent's age, health

But the court will grant visitation rights in the best interest of the child and it does not interfere or destroy the child-parent relationship.<sup>5</sup>

In situations where parents are unable to adequately provide for their children, grandparents frequently step in as guardians for their underage grandchildren. Guardianship, like legal custody, establishes a legal relationship between grandparents and grandchildren through a court order. While grandparents take on the day-to-day caregiving responsibilities, parents retain certain rights. Unlike legal custody, guardianship is typically addressed in probate court.

In some states, guardianships are more enduring than legal custody, lasting until the child reaches 18. Guardians also have some other additional authorities like making medical decisions for the grandchild, adding health care insurance to them, and appointing some other persons as guardians when they are unable to take care of the child. Some states even allow the biological restoration of parent's rights in specific circumstances. Adoption helps in offering stability for the grandchild, especially when the biological parents are not fully ready to commit to parenthood. It need not be adversarial and can be considered, for example, when a parent who gave birth is very young and unprepared for the responsibilities of raising a child.<sup>6</sup>

#### **ELDERLY PARENTS**

Insufficient care facilities in rural areas contribute to many different challenges faced by elderly people, who often struggle with multiple disabilities, and health issues are prevalent as deafness, blindness, disabilities, mental health stability, aging, etc. Also, the absence of adequate housing facilities and the migration of younger generations to urban cities can

Being a grandparent not only causes mental and physical strain but also heightens the desire to return to the workforce to make money.

The current welfare reform ideas, which include a five-year lifetime benefit cap, have lawmakers concerned about the potential financial impact on grandparents' capacity to support their grandchildren. These policies must be adaptable to assist middle-aged or older individuals who are shouldering the financial responsibility of raising their grandchildren. Moreover, under the Social Security Act, custodial grandparenting payments ought to be exempt from income limitations that lower Social Security benefits.<sup>14</sup>

## **MEASURES TO BE TAKEN**

- The monthly sign should be increased to a minimum of Rs.2000 per month.
- For economically disadvantaged elders, housing and policy attention facilities must be provided.
