# THERE ARE THREE PRIMARY CATEGORIES OF SEXUAL ASSAULT

#### Verbal

This includes making inappropriate remarks, inappropriately talking about sexual desires, and making remarks about someone's attire or body in a sexual way that crosses consent lines.

#### Non-Verbal

This type of harassment occurs when someone makes the victim feel uneasy through their actions, gaze, gestures, and body language. For instance, moving from top to bottom while making eye contact, sending sexual signals with hands or body, or displaying sexual images to others in a sexual manner.

Anything that leads to unwanted physical contact is considered physical harassment. This includes actions such as touching, rubbing genital areas, patting or rubbing shoulders, and kissing.

These are the categories of sexual assault that are faced by almost every girl once in life Sometimes these women were so little that they knew that what was happening to them was right or wrong but they have always felt something discomfort and that becomes a trauma after they grow up, things come up in their minds again and again and they realize what they had gone through.

### SEXUAL HARASSMENT IN DOMESTIC PLACE

Domestic Place means the household where one lives. Almost every woman has faced sexual assault in her life at least once. But how does it feel when she faces assault from her own

bloodline or someone who is related to her in her own family? There are many examples where women have faced such discomforts. Women who face such assault from their own uncles, cousins brothers, stepdad, grandfathers, guests, and so on at their own house are known as sexual harassment in the domestic place. Types of harassment include unwelcome sexual advances, inappropriate remarks, and coercive sexual behavior, encompassing acts of subtle intimidation or breach of personal space.

A key feature of harassment within the home environment is the indistinct lines between one's personal and private matters. This lack of clarity can complicate the process for victims to recognize and voice their experiences, frequently resulting in under-reporting and ongoing torture in isolation. Often when a girl at young faces such assault and confronts someone very close to them whether it is her mois ther, sister, father, or brother they often instead of expressing this they chooses to tolerate and keep silent in order to maintain a family relationship that does not lead to any family issue. And then they choose to live with such trauma. Many of the girls who cannot bear such traumas are ending their lives by themselves.

# POWER DISPARITIES AND INEQUALITIES

The root cause of sexual harassment in the domestic household or intimate environment is the issue of power disparities. This disparity may come from differences in age, gender, financial condition, or cultural practices due to which sexual assault takes place. For example, a girl of 12 years may face sexual harassment from her 37-year-old uncle and she is unable to say anything because of the age difference as well as the power disparity due to the difference in the age.

Furthermore due to social norms and beliefs the roles of men and women have always been discriminated against and never treated equally. It also results in sexual intent in households where men think themselves superior to women and treat them abusively by harassing them with sexual acts.

This feeling of being cut off can be made worse by financial dependence or societal values that emphasize the reputation of the family over the happiness of the individual.

Due to such emotional depression, many women take time to recover from such traumas and some really take a long time and are insecure about every man around them, while some end their lives by failing to bear such pain in their hearts.

The impact on women or minors of sexual assault has always resulted in severe depression for the victim.

# ACTIONS VICTIMS CAN TAKE FOR SEXUAL HARASSMENT

Many people feel uneasy about discussing instances of sexual harassment, especially when it happens among family members.<sup>2</sup> They might feel embarrassed or think others don't trust them. Nonetheless, it's crucial for victims not to stay silent about their experiences.

Immediate steps victims can take if they experience sexual harassment include

- ➤ Calling out the offender right away and Discussing the impact of the harassment and the reasons it should stop, also warn them of possible consequences.
- Reaching out to someone that can be trusted, such as a family member, relative, or close friend or any individual victim has confidence who will provide support.
- ➤ Maki a formal complaint or pursuing legal action, or can always contact the women's helpline (7827170170) or start a legal case against the harasser.
- ➤ Collect evidence secretly when facing repeated harassment. Recording inappropriate phone conversations and messages can be used as evidence.

# WOMEN FACING SEXUAL HARASSMENT AT HOME HAVE LAWS FOR SEEKING JUSTICE, INCLUDING

- ➤ <sup>3</sup>Initiating an initial report at the closest police station. The officer assigned is required to document the incident and take appropriate action.
- ➤ The Domestic Violence Act of 2005 addresses all forms of domestic abuse, ranging from physical to mental, emotional, and sexual assault.
- According to section 498A of the Indian Penal Code, assault by a spouse or in-laws can result in a conviction for up to three years.
- ➤ Under section 294 of the Indian Penal Code, the public display of obscene songs or indecent acts can lead to a prison sentence of up to three years.
- ➤ Despite numerous legal protections in place for women, the reality often reflects a distressing situation.
- ➤ Section 375 of the Indian Penal Code excludes the crime of marital rape from being considered as long as the wife is below the age of 15. An important detail is that the law views marriage as granting permanent consent. It is crucial for these laws to be revised to better align with the needs of survivors of domestic violence.
- ➤ Unfortunately, women continue to endure sexual attacks by their partners, family, or relatives. Yet, women should not remain silent about their experiences. It is only through the successful prosecution of offenders that we can inspire more positive societal change. Of Legal Research and Juridical Sciences

#### **REAL-LIFE INCIDENTS**

One of my friends shared how she was sexually assaulted by her brother living in her neighborhood when she was just 7 years old and him being 20 years old. He assaulted her by inappropriate touch again and again for many days and asked her not to say anyone as this was only a game that they both played. The same friend again at the age of 12 years faced inappropriate touch from her own uncle.

A minor girl from a metropolitan city took her life because of the trauma she got from sexual assault from her own uncle.


# **SUGGESTIONS**

It is essential to create a safe and supportive environment where victims feel empowered to speak out and seek help without the fear of judgment or reprisal.




# DATA ANALYSIS


It is confirmed that the form is filled by more females than males.








# Have You felt traumatized about it? 42 responses




It can be seen that many of them felt traumatized y such incidents that occurred to them.








The data shows that few of them face it multiple times and some only once.


Even after such assault you need to face them everyday or in any occassion of family. Is it easy to face them for you or you just don't care about it anymore?
